## Abuse Awareness (SoVA)

*A vulnerable adult is a person aged 18 years or over who may be unable to take care of themselves, or protect themselves from harm or from being exploited. This may be because they have a mental health problem, a disability, a sensory impairment, are old and frail, or have some form of illness.*



*Research suggests that as many as one in eleven older people in the UK are mistreated or neglected by those they trust the most. Two thirds of these are abused by members of their own family. Care staff, too, can be abusers.*

*This course is designed for all involved in the care of vulnerable adults.*
